



IKEA KIDS CLUB MEMBERSHIP SCAN PROMOTIONAL TERMS & CONDITIONS

4. Members under the age of 3 years are entitled to a membership however; the scan function will not be activated until they are 3 years old. Upon a members 3rd birthday their card will be automatically activated.
5. Upon registering you will agree to and abide by all the terms and conditions of the IKEA Kids Club.
6. IKEA Kids Club members may scan their card in store, at the scanning station to receive a free monthly prize, if aged between 3-12 years.
7. All scans will resulting prize awarded randomly with all members having equal chance.
8. Members must scan their membership card at least once a year to remain a member and to continue to receive membership benefits.
9. Membership and benefits are valid only at participating IKEA stores.
10. Membership and benefits are not transferable.
11. IKEA Kids Club benefits are for members only.
