1. IKEA Gift Cards can be used as full or partial payment for any purchase in IKEA stores, excluding the IKEA Restaurant & Bistro/Swedish Food Market, in New South Wales, Victoria & Queensland.
2. Cards cannot be redeemed for cash or balances transferred to new cards.
3. Please keep your Gift Card secure as they are not replaceable if damaged, lost or stolen.
4. Cards remain the property of IKEA Pty Limited, and may not be tampered or interfered with, without our consent.

If you are ordering our Gift cards remotely (Ask Anna, faxed order form or by phone) the following conditions also apply:

5. Once your order has been received, we will contact you to confirm the order and process your payment.
6. We accept payment by VISA or MASTERCARD.
7. A postage and service fee of \$4.00 is payable on all standard orders (does not apply to purchase of Gift Cards in store).
8. Once confirmed, your order will be processed and dispatched within 48 business hours (please also allow time for delivery).
9. In order to protect our customers, deliveries of Gift Cards are made via Australia Post registered mail service to the billing address of the credit card holder.
