Terms & Conditions

- Agreement:** These Terms and Conditions apply in respect of the IKEA Australia Family ‘*Paramount+ - A year of Streams*’ competition (**Promotion**). By submitting an entry to this Promotion, you agree that you have read, understood and agree to be bound by these Terms and Conditions. Information and material used to market the Promotion or to explain how to enter the Promotion forms part of these Terms and Conditions (except that, if there is an inconsistency between that information and material and these Terms, these Terms and Conditions prevail). These Terms and Conditions form a legally binding contract between you and IKEA Pty Limited (“IKEA”, “we”, “us”, “our”, “Promoter”).

Your contact details associated with your IKEA Family membership will be used to contact you should you be selected to be as a winner of a Prize.

Paramount+ requires internet access and a compatible device, neither of which are provided as part of your subscription.
