

IKEA AU Loyalty Members Offer - 10% off Selected IKEA Kitchen Appliances

Effective Date: 3 September 2026 (v1)

Terms & Conditions

1. **Promotion:** During the Promotional Period, IKEA Australia Loyalty Members will receive 10% off the total individual purchase price **of any 3 or more eligible IKEA Kitchen Appliances purchased within a single transaction** (either in-store or online). This offer is only applicable for purchases with IKEA Australia.
2. **Promoter:** The Promoter is IKEA Pty Limited (ABN 84 006 270 757) of 630 Princes Highway, Tempe NSW 2044.
3. **Promotion Period:** The Promotional Period commences at 12:00am (Sydney Time) on **3 September 2026** and ends at 11:59pm (Sydney Time) on **28 December 2026**.
4. **For IKEA Loyalty Members only:** This Promotion is only available to both our IKEA Family Members and IKEA Business Network customers (who present or verify their IKEA Loyalty membership before finalising their transaction)
5. **Selected IKEA Kitchen Appliances only:** The Promotion is applicable only to any IKEA Kitchen Appliances that are not an Excluded Product. To qualify for the Promotion, IKEA Loyalty Members must purchase **three (3) or more eligible IKEA appliances within a single transaction**. IKEA Loyalty Members will see an automatic reduction (corresponding to this Promotion discount) applied to the total amount to be paid for the transaction once their IKEA membership details have been scanned or inserted.
6. **Excluded Products:** The following products are excluded from this Promotion:
 - a. Article no. 404.935.09 - **TILLREDA** portable induction hob;
 - b. Any appliance accessories, spare parts, fittings, maintenance products, or service products;
 - c. Delivery, assembly, installation, measurement, removal or any other IKEA services (irrespective of whether it is for any IKEA Kitchen);
 - d. Any 'As-Is' products; and/or
 - e. Any gift cards (even if they are to be used towards purchased under this Promotion).

7. **In-store Redemption:** For in-store redemption IKEA Loyalty Members must scan their IKEA Family card, IKEA Business Network card, or provide their registered mobile number before completing their purchase.
8. **Online Redemption:** Customers must be logged into their IKEA Family or IKEA Business Network account when completing their purchase on IKEA.com.au or through the IKEA App.
9. **Availability and Stock Limits:** All items are advertised in good faith to be available during the Promotion. However, unforeseen problems or unexpected demand may occasionally result in stock being unavailable. Stock availability may vary between stores and online. The Promotion is valid while stocks last. No rainchecks will be offered.
