Please note: These Terms and Conditions are only applicable for the (physical) Voucher that was issued to IKEA Family Members as part of the IKEA Activation “Waste Less, Contain more” at several NSW locations throughout July 2026. The Voucher cannot be re-issued by our Remote Customer Service team.

- Promotion:** During the Promotional Period, IKEA Family members issued with a Voucher may redeem that voucher in-store towards a **15% discount off** the regular price on IKEA Swedish food market products. This Voucher cannot be redeemed online. To redeem, you must redeem at a Participating Store.

- IKEA Loyalty Members only:** This Promotion is only available to our IKEA Family Members (who present or verify their IKEA Loyalty membership before finalising their transaction).
