

# IKEA Loyalty Members Offers – \$5 Voucher with every Children’s meal purchase

## Terms & Conditions

- Promotion:** During the Promotional Period, purchase any Children’s meal and receive a \$5 voucher (**Voucher**) to redeem towards our IKEA Children’s range for every meal purchased. Multiple meal purchases will have a total Voucher value issued proportionate to the number of Children’s meals that has been purchased in a single transaction.
- Promoter:** The Promoter is IKEA Pty Limited (ABN 84 006 270 757) of 630 Princes Highway, Tempe NSW 2044.
- For IKEA Loyalty Members only:** This Promotion is only available to both our IKEA Family Members and IKEA Business Network customers (who present or verify their IKEA Loyalty membership before finalising their transaction).
- Promotion Period:** The Promotional Period is from [5 March 2026](#) and ending on [5 April 2026](#) (and only during trading hours of the Swedish Restaurant at any of our IKEA Australia Retail Stores).
- Conditions of Redemption:** The following conditions applies to the redemption of the issued Voucher:
  - Valid only on product(s) from our IKEA Children's range
  - Valid only on the date of issue
  - Must be redeemed in person at the issuing store (cannot be redeemed online).
  - Voucher is only activated upon a valid IKEA Family membership account scanned within the same transaction in-store
  - Cannot be redeemed for cash
  - Only one voucher will be accepted within a single transaction for redemption.
- Availability and stock limit:** All menu items are advertised in good faith to be available at time of the offer. However, unforeseen problems or unexpected demand may occasionally result in unavailability. Please note availability of meals varies between stores and online and not all meals will be available in stores.

7. **Only one offer at a time:** The Promotion is not available in conjunction with any other special, discount, promotional offer or any other IKEA Family member and/or IKEA Business Network member offers (unless the contrary has been expressed).
8. **No transfer or cash redemption:** The Voucher is not transferrable and cannot be redeemed for cash towards other IKEA products.
9. **Validation and Verification:** Eligibility to the Promotion will be subject to the Promoter's validation and verification checks. Promoter's decision is final.
10. **Right to withdraw:** The Promoter reserves the right to withdraw the Promotion at any time during the Promotion Period. We will communicate a withdrawal on our IKEA website. No withdrawal notification will be individually communicated to the Customer.
11. **Right to change:** The Promoter reserves the right to change these Terms and Conditions from time to time to reflect changes to the law or changes to our services including (but not limited to) eligibility and the Promotional Period. Customers shall review these Terms and Conditions on a regular basis for updates before commencing their transaction. No changes will be individually communicated to the Customer.
12. **Right to correct and adjust:** While great care has been taken to ensure accuracy of all prices and descriptions, the Promoter reserves the right to correct any errors and adjust prices and charges including GST, customs duty or other statutory charges. No corrections or adjustments will be individually communicated to the Customer.
13. **Limitation of Liability:** The Promoter shall not be liable for any loss or damage whatsoever suffered (including but not limited to indirect or consequential loss) or for personal injury suffered or sustained because of any participation in the Promotion, except for any liability which cannot be excluded by law.
