# 6 *Workers'* health and safety are protected

## OCCUPATIONAL HEALTH AND SAFETY MANAGEMENT

### BASIC

- LT 6.1 Traffic rules, including speed limits, are respected.
- LT 6.2 *Workers* do not consume alcohol or drugs prior to driving or while driving.

### ADVANCED

- LT 6.3 Road safety risk assessments are conducted taking into consideration transportation security risks and safety hazards. Highest risk routes are avoided.

## EMERGENCY MANAGEMENT

### BASIC

- LT 6.4 Drivers have access to a support system 24 hours a day, 7 days a week.

# 8 The planet is protected

## AIR POLLUTION AND CLIMATE

### BASIC

**LT 8.1** Vehicles used for IKEA goods are compliant with the national emissions requirements as per below:

Trucks (gross vehicles weight > 3500 kg)

- Fulfil the national engine emissions standards but in no case truck age shall be older than 10 years.
- If no national emission standard, truck age is maximum 10 years old.
- For trucks using alternate fuels, trucks that are more than ten years old and fulfill nation engine emission standards are acceptable to be used for IKEA transport.

Trucks (gross vehicle weight ≤ 3500 kg)

- Fulfil the national engine emissions standards of 5 years old or less.
- If no national emission standard, truck age is maximum 5 years old.
- For trucks using alternate fuels, trucks that are more than ten years old and fulfill nation engine emission standards are acceptable to be used for IKEA transport.

A list of vehicles used for IKEA related operations is maintained and includes the equivalent national engine emissions standards, or if a national standard does not exist, the vehicle age and the country of registration.

### EXCELLENT

**LT 8.2** Vehicles used for IKEA goods are powered by *alternative fuels*.

# Glossary

<b>Alternative fuels</b>	Non-conventional fuels which include renewable and <i>zero emission fuels</i> and exclude fossil-based and nuclear fuels.
<b>Safe place</b>	A parking place that prevents threats to the security of drivers, vehicle, and cargo.
<b>Truck age</b>	The trucks age is calculated starting at the end of the first calendar year independently of when, during the first year, the truck was registered.
<b>Workers</b>	A person performing work full-time or part-time. This includes piece rate <i>workers</i> , vocational trainees and <i>workers</i> undergoing a probationary period, as well as sub-contractor <i>workers</i> .
<b>Zero emission fuels</b>	<p>Fuels with no direct emissions of air pollutants when used as an energy source (called scope 1 emissions, according to the Greenhouse Gas Protocol). Emissions of air pollutants from fuel production (called scope 2 and scope 3 emissions, according to the Greenhouse Gas Protocol) are not included in the classification of a fuel as zero emission.</p> <p>Zero emission fuels include electricity and hydrogen (e.g., in batteries and fuel cells) and exclude biofuels (e.g., biogas and biodiesel).</p>
