

TERMS AND CONDITIONS IKEA FAMILY MARKER WADDEN GIVEWAY

By participating in the IKEA Family Marker Wadden Giveaway, you accept these <u>terms and conditions</u>. Please also read our <u>privacy statement</u>, which explains how we process the personal data you share with us when you participate in the IKEA Giveaway.

Who is organizing this giveaway?

The organizer of this giveaway is IKEA B.V., Laan van Decima 1, (2031 CX) Haarlem (hereinafter: "IKEA").

This giveaway applies to www.ikea.nl and all IKEA stores of IKEA B.V. in the Netherlands.

2. What is the campaign period?

You can register for the IKEA Giveaway from November 22, 2024, to December 8, 2024.

3. What is IKEA promoting with this IKEA Giveaway?

With this IKEA Giveaway, IKEA is promoting its vision on sustainable living, whether at home or on vacation. In the cottages on the Marker Wadden, you will find sustainable IKEA products, such as energy-efficient appliances and lighting, water-saving faucets, and products made from natural and recycled materials. IKEA shows that sustainability goes hand in hand with attention to design and comfort.

4. How can you participate in the IKEA Giveaway?

IKEA Family members can register for the IKEA Giveaway via this online registration form.

Answer the following question: Which IKEA product would you take to a deserted island?

Through the registration you provide your name and the email address linked to your IKEA Family account to IKEA and your preference for the weekend or midweek (see paragraph 6).

You can only participate if you are a member of IKEA Family. If you are not yet an IKEA Family member, you can sign up here.

You can participate a maximum of once during the campaign period and win a maximum of one prize.

Minors need permission from a parent or legal guardian to participate.

Participation is excluded for IKEA employees. The IKEA Giveaway is not valid in combination with other offers and/or promotions.

5. Are there any (communication) costs associated with participation?

There are no (communication) costs associated with participation in the IKEA Giveaway.

6. What prizes can you win?

Among all participants, IKEA will raffle four stays suitable for four people on the Marker Wadden during the following weekend and midweek:



- a) two stays during the weekend from Friday, February 7, 2025, to Monday, February 10, 2025; and
- b) two stays during the midweek from Monday, February 10, 2025, to Friday, February 14, 2025.

The arrival and departure dates cannot be adjusted due to the ferry service that only departs to and from the Marker Wadden on Fridays and Mondays.

A stay represents a value between EUR 450 and EUR 520.

The prizes cannot be exchanged for cash. It is not allowed to resell, transfer, or use the prizes for commercial purposes.

IKEA reserves the right to replace the prize with a prize of equal or higher value if the original prize is no longer available due to circumstances.

7. How does IKEA select the winners?

IKEA will select four winners in a random and impartial manner by December 13, 2024.

8. How do you know if you have won?

When you participate in the IKEA Giveaway, you share your name, phone number, and the email address linked to your IKEA Family account. If you win, IKEA will send you an email around December 13, 2024 with the details of the prize you have won.

If the winner does not respond within fourteen days, the right to the prize expires, and IKEA may select a new winner.

The result communicated by IKEA is final. IKEA will not correspond about the result.

9. Are you liable for gambling tax on your prize?

IKEA pays the gambling tax on the prize you have won.
