



**TERMS AND CONDITIONS FOR IKEA FAMILY LOWLANDS GIVEAWAY

**1. Who is organizing this giveaway?**

The organizer of this action is IKEA B.V., Laan van Decima 1, (2031 CX) Haarlem (hereinafter referred to as "IKEA").

**2. What is IKEA promoting with this giveaway?**

**3. What is the action period?**

You can participate in the IKEA Family Giveaway from June 18, 2024, to June 30, 2024.

**4. How can you participate in this giveaway?**

This giveaway is for all IKEA Family members who sign up via the [online registration form](#).

You can register by providing your details linked to your IKEA Family account and answering the following question:

Minors need permission from a legal guardian to participate.

IKEA employees are excluded from participation.

**5. Are there any participation (communication) costs involved?**

There are no participation (communication) costs associated with entering the IKEA Family Giveaway.

**6. What prize can you win?**

IKEA is giving away forty pairs of tickets to Lowlands 2024, the three-day festival in Biddinghuizen, taking place from August 16 to August 18, 2024. A winner will receive two tickets from IKEA, providing free access to the festival grounds for two people.
