



TERMS AND CONDITIONS OF THE PROMOTION
IKEA FAMILY – RECEIPT PRIZE DRAW

1. Who is organizing this promotion?

The organizer of this promotion is IKEA B.V., Laan van Decima 1, (2031 CX) Haarlem (hereinafter: “IKEA”).

2. What is IKEA promoting with this action?

3. What is the promotion period?

You can register for the promotion from August 1, 2024, to August 31, 2024.

4. How can you participate in the promotion?

As an IKEA Family member, you can participate in the promotion in the following two steps:

1. Scan your IKEA Family card when purchasing IKEA products in an IKEA store or online at www.ikea.nl between August 1 and August 31, 2024.
2. Register for the promotion via the [online registration form](#) with:
 - a) The details linked to your IKEA Family account (your name, phone number, and email address). Ensure these are correctly filled in so we can contact you if you win;
 - b) The receipt number of your purchase. The receipt number is a 22-digit number starting with 99.

You can participate a maximum of once during the promotion period and win no more than once.

Minors need permission from a legal guardian to participate.

Employees of IKEA are excluded from participation.

5. Are there any (communication) costs associated with participation?

There are no (communication) costs associated with participating in the promotion.

6. What prizes can you win?

Among the winners, IKEA distributes 210 IKEA gift cards worth EUR 400 each and 12 IKEA gift cards worth EUR 1000 each. The gift card cannot be returned for cash. For purchases below the value of the IKEA gift card, IKEA will not return the remaining balance in cash. Any remaining balance will stay on the IKEA gift card. If you return IKEA products purchased with the IKEA gift card, you will receive the value back on an IKEA credit card.

7. How does IKEA select the winners?

From all participants, IKEA will randomly select the winners every week in August and the first week of September 2024. In total, IKEA will select 210 winners for the EUR 400 IKEA gift card and 12 winners for the EUR 1000 IKEA gift card in four draws. In the first three weeks, IKEA will select 50 winners each week for the EUR 400 IKEA gift card and 3 winners for the EUR 1000 gift card. In the last week, IKEA will select 60 winners for the EUR 400 IKEA gift card and 3 for the EUR 1000 IKEA gift card.

When you participate in the promotion, you share the details linked to your IKEA Family account (your name, phone number, and email address). If you have won, you will receive an email from IKEA Family Events before September 10, 2024. Make sure to check your spambox.
