

## 2024 IKEA FAMILY SURVEY SWEEPSTAKES New Lower Prices Survey

### **OFFICIAL SWEEPSTAKES RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT ENHANCE CHANCES OF WINNING. VOID WHERE PROHIBITED.**

**1. How to Enter:** This monthly sweepstakes begins January 22, 2024 and ends February 29, 2024 and is entered via survey link emailed to IKEA FAMILY members, complete the online survey and opt into the sweepstakes by entering a valid email address and other information requested, and submit. Only one entry per person/e-mail address is permitted. You must have internet access in order to enter the Sweepstakes. All entries submitted become the sole property of IKEA and will not be returned. By participating, entrants agree to be bound by these Official Rules.

**2. Sponsor:** IKEA, U.S. 420 Alan Wood Road Conshohocken, PA 19428

**3. Prize:** One (1) winner per Sweepstakes period will receive an IKEA gift card, valued at approximately \$100.00. All prizes will be awarded and are not transferable or redeemable for cash. The winner is responsible for all federal, state and local taxes on the prize and for delivery and assembly of IKEA merchandise, where required. IKEA is not responsible for lost or stolen gift cards. Prize is valid in IKEA US stores only. Any portion of prize not used by winner is forfeit and no cash substitute will be offered.

**4. Selection of Winners:** IKEA will randomly select one winner from all eligible entries received, and will notify the winner by email. IKEA's selection of the winner is final. IKEA and its agents will not be liable for inability to notify the winner, whether due to inaccurate entry information, change of email address or otherwise. Winners will have fifteen (15) business days from notification to complete affidavit to claim their prize and a winner who does not respond in this time period will be deemed to have forfeited the prize and an alternate winner may be selected.

**5. Release:** IKEA will require the winner to sign and return an affidavit of eligibility and liability release form and a W-9 form as a condition to receipt of the prize. If such documents are not returned within the time period requested, or if an entrant is found to be ineligible or if he/she does not comply with the Official Rules, then the potential winner will be disqualified and an alternate winner will be selected.

**6. Eligibility:** Sweepstakes open to legal residents of the United States who are 18 years old or age of majority at time of entry.
