

## **IKEA Schaumburg “2023 Teacher Appreciation Event” SWEEPSTAKES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW.

**DESCRIPTION:** The “Teacher Appreciation Event” Sweepstakes (the “**Sweepstakes**”) begins on 7/15/2023 at 10 am Central Daylight Time (“**CDT**”) and ends at 2:30 pm CDT on 7/15/2023 (“**Sweepstakes Period**”). One (1) potential Prize (as defined below) winner will be randomly drawn from all eligible entrants at the IKEA Schaumburg store (“**Participating Store**”) during the Sweepstakes Period. By participating in the Sweepstakes, each entrant agrees to comply with and abide by these official rules and the decisions of IKEA Schaumburg located at 1800 McConnor Pkwy, Schaumburg, IL 60173.

1. (“**Sponsor**”), which shall be final and binding in all respects.
2. **ELIGIBILITY:** Open to i) legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (nineteen (19) in AL and NE) or older at the time of entry, ii) who are registered members in good standing of the IKEA Family Program at the time of entry, iii) and iv) also show educator proof (school or teacher ID or similar homeschool certification letter) during the Promotion Period. Entrants may not create additional IKEA Family Program memberships for additional entries. Sponsor is not responsible for lost, late or invalid entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic.
4. **WINNER SELECTION:** One (1) Prize winner will be randomly selected on or about 07/15/2023 from among all eligible entries received during the Sweepstakes Period.
5. **WINNER NOTIFICATION:** Potential Prize winner will be notified Sponsor shall have on the spot in-person no liability for any winner notification that is not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond, such potential winner will forfeit his or her Prize and an alternate winner may be announced. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a Prize in accordance with the above procedure, after which the Prize in question may go unawarded if it remains unclaimed.
