

IKEA WEST SACRAMENTO TWENTIETH ANNIVERSARY SWEEPSTAKES –
3/1/2026

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW.

1. **DESCRIPTION:** The IKEA West Sacramento Twentieth Anniversary Sweepstakes (the “**Sweepstakes**”) begins on March 1, 2026 at 10:00 a.m. Pacific Daylight Time (“**PDT**”) and ends on March 1, 2026 at 6:59 p.m. PDT (“**Sweepstakes Period**”). Two Hundred (200) potential Prize (as defined below) winners will be selected at the IKEA West Sacramento store (“**Participating Store**”) during the Sweepstakes Period. By participating in the Sweepstakes, each entrant agrees to comply with and abide by these official rules and the decisions of IKEA West Sacramento located at 700 IKEA Circle, West Sacramento (“**Sponsor**”), which shall be final and binding in all respects.
2. **ELIGIBILITY:** Open to i) legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (nineteen (19) in AL and NE) or older at the time of entry, and ii) who are registered members in good standing of the IKEA Family Program at the time of entry. Employees of Sponsor, the Participating Store, its parent company, affiliates, subsidiaries, partners, advertising and Sweepstakes agencies (collectively, “**Sweepstakes Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. Sponsor is not responsible for lost, late or invalid entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic.
4. **WINNER SELECTION:** Two Hundred (200) Prizes will be awarded on or about March 1, 2026 to the first Two Hundred (200) eligible Sweepstakes entrants.
5. **WINNER NOTIFICATION:** Potential Prize winners will be notified in person at the time of the winner selection. Sponsor shall have no liability for any winner notification that is not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond, such potential winner will forfeit his or her Prize and an alternate winner may be announced. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a Prize in accordance with the above procedure, after which the Prize in question may go unawarded if it remains unclaimed. If any potential Prize

winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the Prize for any reason prior to award, such Prize will be forfeited, and an alternate Prize winner may be selected.
