

IKEA Centennial Teacher Appreciation SWEEPSTAKES

By participating in the Sweepstakes, each entrant agrees to comply with and abide by these official rules and the decisions of IKEA Centennial located at IKEA Centennial, 9800 E. IKEA Way, Centennial, CO 80112, United States (“**Sponsor**”), which shall be final and binding in all respects.
2. **ELIGIBILITY:** Open to i) legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (nineteen (19) in AL and NE) or older at the time of entry, ii) who are registered members in good standing of the IKEA Family Program at the time of entry, iii) previously RSVP'ed using the online event page available at Store Event Co-Worker Frontend - IKEA and (iv) be a valid IKEA Family member at the time of participation. Sponsor shall have no liability for any winner notification that is not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond, such potential winner will forfeit his or her Prize and an alternate winner may be announced. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential
