

IKEA FISHERS “GET READY FOR COLLEGE VIRTUAL WORKSHOP”
SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW.

1. **DESCRIPTION:** The “IKEA Fishers Get Ready for College Virtual Workshop” Sweepstakes (the “**Sweepstakes**”) begins on 7/20/2023 at 7 *pm* Eastern Daylight Time (“**EDT**”) and ends at 7:30 *pm* EDT on 7/20/2023 (“**Sweepstakes Period**”). One (1) grand prize winner (4) potential prize (as defined below) winners will be randomly drawn from all eligible entrants at the IKEA Fishers store (“**Participating Store**”) during the Sweepstakes Period. By participating in the Sweepstakes, each entrant agrees to comply with and abide by these official rules and the decisions of IKEA Fishers located at 11400 IKEA Way, Fishers, IN, 46037 (“**Sponsor**”), which shall be final and binding in all respects.
2. **ELIGIBILITY:** Open to i) legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (nineteen (19) in AL and NE) or older at the time of entry, ii) who are registered members in good standing of the IKEA Family Program at the time of entry, iii) previously RSVP’ed using the online event page available at www.ikea.com/us/en/stores/fishers/ and iv) in attendance of the Get Ready for College virtual workshop. 5. **WINNER NOTIFICATION:** Potential grad prize winner and prize winners will be notified *via email* . Sponsor shall have no liability for any winner notification that is not received by a potential winner for any reason.
