

2025 IKEA SURVEY SWEEPSTAKES FOR IKEA POST-PURCHASE SURVEY

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT ENHANCE CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. How to Enter: This sweepstakes begins January 30th and ends February 15th, 2025, and is entered via survey link emailed to participants, complete the online survey and opt into the sweepstakes by entering your name, valid email address and other information requested, and submit. Only one entry per person/e-mail address is permitted. You must have internet access in order to enter the Sweepstakes. All entries submitted become the sole property of IKEA and will not be returned. By participating, entrants agree to be bound by these Official Rules.

3. Prize: One (1) winner per Sweepstakes period will receive an IKEA gift card, valued at approximately \$100.00. All prizes will be awarded and are not transferable or redeemable for cash. The winner is responsible for all federal, state and local taxes on the prize and for delivery and assembly of IKEA merchandise, where required. IKEA is not responsible for lost or stolen gift cards. Prize is valid in IKEA US stores only. Any portion of prize not used by winner is forfeit and no cash substitute will be offered.

5. Eligibility: Sweepstakes open to legal residents of the United States who are 18 years old or age of majority at time of entry. The Sweepstakes is void in Puerto Rico, Guam, U.S. Territories and outside of the United States, and where restricted or prohibited by law.
