## 2025 IKEA ONLINE CART SURVEY SWEEPSTAKES US Online Cart Survey

## OFFICIAL SWEEPSTAKES RULES ("Official Rules")

- **1. Overview:** The 2025 IKEA Online Cart Survey Sweepstakes ("Sweepstakes") begins February 5, 2025 and ends March 7, 2025 ("Sweepstakes Period"). This sweepstakes begins at 12:00:01 am Eastern Standard Time ("ET") on the first day of the sweepstakes period and closes at 11:59:59 pm ET on the last day of the sweepstakes period. You must have internet access in order to enter the Sweepstakes. By participating, entrants agree to be bound by these Official Rules.
- **2.** <u>Sponsor</u>: IKEA North America Services, LLC, 420 Alan Wood Road Conshohocken, PA 19428 ("Sponsor").
- 3. How to Enter: Those who wish to participate may enter by clicking the survey link, and complete the online survey by entering their name, valid email address, and other information requested, and submit. By submitting the requested form, you will receive one (1) entry into the Sweepstakes. LIMIT: Only one entry per person/e-mail address is permitted. Sponsor is not responsible for incorrect, inaccurate, or illegible entry information. Those who do not follow all of these instructions or abide by these Official Rules or other instructions of Sponsor may be disqualified. In the event that an entrant enters multiple times into a single Sweepstakes Period, only the first eligible entry during the respective Sweepstakes Period will be counted, and all subsequent entries will be disqualified. Entries into the Sweepstakes exceeding the maximum permitted amount will be void. Entrants may not create additional email addresses for additional entries. Sponsor is not responsible for lost, late or invalid entries, which will be disqualified, or for problems of any kind, whether mechanical, human, or electronic. Unclaimed Prizes will not be awarded. Winner is solely responsible for all federal, state, and local taxes on the Prize. Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by Sponsor. No returns/exchanges. Prize is valid in IKEA US stores only. **5.** <u>Selection of Winners</u>: On or around the 10th (10<sup>th</sup>) calendar date of the month following the Sweepstakes Period, Sponsor will randomly select one (1) potential winner from among the eligible entries submitted during the Sweepstakes Period. Sponsor will notify each potential winner by email provided during entry. There will be a total of one

- (1) potential winner per Sweepstakes Period. Potential winners are subject to verification of eligibility. A winner will have five (5) business days from notification to respond to the email received in order to claim their Prize and a winner who does not respond in this time period will be deemed to have forfeited the Prize and an alternate winner may be selected.
